Town of Ixonia Town Board Minutes May 8th, 2017

1. Call to Order, Roll Call and Pledge of Allegiance

Chairman Goetsch called the meeting of the Town of Ixonia Town Board 7:00 p.m.

Roll call was taken with the following in attendance: Chairman Perry Goetsch, Supervisor Brian Derge, Supervisor Carl Jaeger, Supervisor Jeff Taylor and Supervisor Peter Mark.

Also Present: Attorney Stan Riffle, Deputy Clerk/Treasurer Jodi Jaeger, Utility Plant Manager Jeff Wegner and Clerk/Treasurer Nancy J. Zastrow.

2. Proof of Posting and Notice

The agenda was posted at the Town Hall, Post Office and Ixonia Bank and published in the Watertown Daily Times and also posted on the website.

3. Approval of Minutes – April 10th, 2017

Supervisor Jaeger moved to approve the April 10th, 2017 minutes as presented. Supervisor Derge seconded the motion and carried unanimously.

4. Treasurer's Report

a) Presentation of Revenue and Expense Report for April 2017

Supervisor Jaeger moved, seconded by Supervisor Derge to accept the Revenue and Expense report for April 2017. Motion carried.

- 5. <u>Jefferson County Sheriff's Department Report and/or Jefferson County Supervisor Report</u>
 Officer Brad Reisen was present. There were no updates from the Sheriff's Department and no concerns from residents.
- 6. <u>Discussion and Possible Action regarding a request received at the 2017 Annual Meeting to create an ordinance referencing Manure Hauling and also creation of an Ad-Hoc committee to address the ordinance.</u>

Chairman Goetsch asked the board what they would like to do with the motion which was presented at the Annual Meeting held in April. The motion was to create an Ad-Hoc committee to research an ordinance on manure hauling. Goetsch stated he would like the committee to consist of 5-7 members and the appointment of members would be brought back at the June board meeting.

Supervisor Taylor inquired what would the committee discuss and what the structure and authority of the committee be. He is concerned with what does the Town Board have authority over and what don't we have authority to do. Chairman Goetsch stated the committee would need to meet to address this and bring back their thoughts.

Supervisor Mark asked for clarification if the committee drafts an ordinance it still would need to come before the Town Board for approval. Chairman Goetsch noted this committee would BEadvisory and the decision to adopt an ordinance or not comes from the Town Board.

Supervisor Derge asked Attorney Riffle if any other communities have this type of issue. Attorney Riffle noted this is the first time he has come across this with residents in a municipality. He noted

most community's welcome farms. Attorney Riffle also noted he and Chairman Goetsch have been in communication about the expansion and there is nothing the Town can do to stop it. This is authorized by the State. He suggested working with the operator to work out the issues. Attorney Riffle also noted he has not spent any time researching any part of this, but there are tons of examples available. Attorney Riffle did point out that a manure hauling ordinance would affect every farmer in the community.

Supervisor Mark stated if a committee is created he would like to see a specific time-line. He does not want to see the committee open ended.

Supervisor Derge moved to authorize the Town Chairman to create an Ad-Hoc Committee to review and bring back to the Town Board any recommendations on creation of a Manure Hauling ordinance and to see if they are able to bring something to the board. Supervisor Jaeger seconded the motion and carried.

7. <u>Discussion and Possible Action regarding Six-Month Class "B" Beer and Fermented malt license for Ixonia Youth Baseball – Kevin Kendellen, Agent.</u>

Clerk/Treasurer Zastrow explained the application had been submitted for the Six-Month Class "B" beer and fermented malt for the Ixonia Youth Baseball. She noticed on the form the Wisconsin Direct Sellers number was not listed and suggested approval be granted contingent on obtaining this number and a copy of the state withholding number.

Supervisor Taylor moved, seconded by Supervisor Derge to approve the Six-Month Class "B" Beer and Fermented mail license for Ixonia Youth Baseball – Kevin Kendellen, Agent, contingent on obtaining the Wisconsin Seller's Permit number as required on the application. Motion carried.

8. Discussion and Possible Action regarding Operator Licenses for: Scott Hammer, Ixonia Hardball Diamond; Mary Plutchack, Ixonia Hardball Diamond; Jane Carey, Ski Slide Park Clerk/Treasurer Zastrow presented the following applications for Operator License expiring on June 30, 2017: Scott Hammer, Mary Plutchack and Jane Carey. Background checks were performed and staff recommends approval.

Supervisor Jaeger moved, seconded by Supervisor Derge to approve as presented. Motion carried.

9. <u>Discussion and Possible Action regarding Distribution Easement received from WE Energies</u> for relocation of natural gas line on Elmwood Avenue located by Transfer Site and Utility <u>District #1</u>

Attorney Riffle explained he has reviewed the easement and approval of these documents authorizes WE Energy to move the current location of the natural gas line. This is required as part of the reconstruction of County Hwy P.

Supervisor Derge moved, seconded by Supervisor Mark to approve the distribution easements received from WE Energy. Motion carried.

10. Park & Recreation:

a) <u>Discussion and Possible Action regarding wages for park maintenance employees – Dave Krueger and Dan Zautner</u>

Supervisor Mark explained these two employees currently work at the Recycling Center and are compensated at \$13.40 per hour. Mr. Zautner also currently mows at the Town Hall and is paid \$13.40 to mow. Supervisor Mark is asking the board to authorize Mr. Zautner and Mr. Krueger to be compensated at the same rate of pay as they are currently receiving.

Supervisor Derge feels the increase is worth it. These men a familiar with the equipment and the experience is worth the increase.

<u>Supervisor Taylor moved, seconded by Supervisor Derge to pay Dave Krueger and Dan Zautner \$13.40 per hour for working for the Park & Recreation Department. Motion carried.</u>

11. Fire Department:

a) <u>Update on monthly report for Town of Ixonia, Town of Watertown and Town of Concord</u>

The monthly report was presented. No action was required.

b) <u>Discussion and Action regarding application for Firefighter Recruit Thomas J.</u> Fenwick

Supervisor Jaeger moved, seconded by Supervisor Mark to approve Thomas Fenwick's application for Firefighter. Motion carried.

c) <u>Acceptance of resignation of Patrick Schultz as Captain – will remain active in department</u>

Supervisor Mark moved, seconded by Supervisor Taylor to accept the resignation of Patrick Schultz as Fire Department Captain effective June 1st. Mr. Schultz will remain an active member of the department. Motion carried.

d) <u>Discussion and possible action regarding LifePak 12 Cardiac Monitor support expiring 01-01-2018</u>

Chief Schilling and EMS Director Jim Graf wanted to make the board aware this Capital item will be on the upcoming meetings. This is a vital piece of equipment for the department and the support for the monitor will expire on January 1, 2018. No action was taken – informational only.

12. Highway Department:

a) Accept bid for mowing Pipersville cemetery

The Highway Department received one bid for mowing the cemetery on Hwy E in Pipersville. Jaeger Lawn Care submitted a bid for \$120 per mowing.

Supervisor Taylor moved, seconded by Supervisor Mark to approve Jaeger Lawn Care to mow the Pipersville Cemetery at a rate of \$120 per mowing. Motion carried. Supervisor Jaeger abstained.

13. Utility District:

a) <u>Discussion and Possible Action regarding quotes for pump equipment</u>
Utility Plant Manager Wegner explained he has researched replacing the current pump for Utility
District #1. This would replace the existing pump that is old and worn out and not repairable. The
new pump is used and has a 90-day warranty on it. He is recommending purchasing the pump from
Lincoln Contractor Supply at a cost of \$26,000.

Chairman Goetsch explained this is a backup pump. Wegner noted they use this when pumping holding tanks.

Supervisor Mark moved, seconded by Supervisor Derge to accept the bid for a used pump and hoses not to exceed \$26,000. Motion carried.
